

COVID travel guide for Ukraine

ENTRY REQUIREMENTS:

FOR CUSTOMERS TRAVELLING FROM THE UK	
To enter the country you will need to show:	
<ul style="list-style-type: none"> That you are fully vaccinated against COVID OR <ul style="list-style-type: none"> That you have received a negative COVID test no more than 72 hours before arrival. AND <ul style="list-style-type: none"> That you have travel insurance that covers COVID; insurance must be purchased from a company that has a registered office or partner in Ukraine. 	<p>The NHS Covid pass for travel accepted to demonstrate your COVID vaccination status. For more information please click here.</p> <p>This can be either a PCR or Rapid Antigen Test. Free NHS tests are not accepted; please use a private testing provider. More information on this is available here.</p> <p>Please contact your travel insurance provider to confirm they fulfil this requirement. The Exodus travel insurance policy is underwritten by Allianz, who have a registered office in Ukraine. Full details are here.</p>
Upon arrival you will:	
<ul style="list-style-type: none"> Show evidence of your vaccination status OR negative test result Take an express COVID test; you will need to return a negative result before being allowed to enter Ukraine. 	<p>Please ensure you have the correct evidence/certificates with you before you depart.</p> <p>The arrival test costs 650 Ukrainian Hryvnia (approx. £18) and can be paid using credit card or cash.</p>

10 days	<input type="checkbox"/> Obtain your NHS COVID Pass for Travel (if fully vaccinated)
10 days	<input type="checkbox"/> Book your test to enter Ukraine (if not fully vaccinated) and PCR test to be taken after your return home.
72 hours	<input type="checkbox"/> Take your COVID test (if not fully vaccinated)
48 hours	<input type="checkbox"/> Check in online & expect to supply copies of entry documentation

FOR CUSTOMERS TRAVELLING TO THE UK	
<i>Time before travel</i>	
72 hours	<input type="checkbox"/> If applicable, take your return to UK test – this will depend on your vaccination status and in which part of the UK you reside. For full information on this please check here .
48 hours	<input type="checkbox"/> Complete your UK arrivals Passenger Locator Form (link here)
48 hours	<input type="checkbox"/> Check in online and expect to supply copies of entry documentation
Return home	<input type="checkbox"/> Show your entry documents to UK immigration <input type="checkbox"/> Take your PCR test(s) – either day 2 only or day 2 and day 8 (depending upon your vaccination status)
