

# **COVID** travel guide for Cyprus

### **ENTRY REQUIREMENTS:**

#### FOR CUSTOMERS TRAVELLING FROM THE UK

#### Upon arrival at Larnaca Airport, you will need to:

Show that you are fully vaccinated against COVID

The NHS COVID Pass for Travel is accepted to demonstrate your COVID vaccination status. For guidance on how to obtain this please go here.

Show your Cyprus Flight

You must obtain your Cyprus Flight Pass prior to travel. More information on this is found below.

### To enter North Cyprus, at the checkpoint you will need to show:

That you are fully vaccinated against

# COVID

That you have obtained a Digital Travel Document

The NHS 'COVID Pass' is also accepted to demonstrate your COVID vaccination status but must be in printed format. A digital copy/QR code may not be accepted.

The Digital Travel Document is compulsory for all people wishing to enter North Cyprus. More information on this is found below.

It is possible to enter Cyprus if you are not fully vaccinated; there are, however, complex requirements in place, which include taking numerous COVID tests and self-isolating while you await results. Due to the impact this would have on the ability for unvaccinated individuals to fully participate in the trip, we are therefore only able to accept fully vaccinated customers on Exodus trips in

- Obtain your Digital Travel Document
