

## COVID travel guide for Italy

### ENTRY REQUIREMENTS:

FOR CUSTOMERS TRAVELLING FROM THE UK	
<p><b>There are no specific entry requirements for Italy in relation to COVID. All travellers will therefore need to fulfil Exodus' COVID-Clear policy. Full details on this can be found <a href="#">here</a>.</b></p>	
<p><b>Prior to your trip, you will need to either:</b></p>	
<ul style="list-style-type: none"> <li>Be fully vaccinated against COVID</li> </ul> <p><b>OR</b></p> <ul style="list-style-type: none"> <li>Receive a negative COVID test result before travelling</li> </ul>	<p>The total number of doses must have been given, as required by the vaccine manufacturer (in most cases this is two doses), with the last dose having been administered no less than two weeks prior to travel.</p> <p>Please obtain a copy of your NHS COVID Pass for Travel and have this readily available during your trip. For guidance on how to obtain this, please go <a href="#">here</a>.</p> <p>If you are not fully vaccinated, please take a COVID test no more than 72 hours before departure. This can be either a PCR or lateral flow test.</p> <p>This must be a private test; information on COVID testing and private providers can be found <a href="#">here</a>.</p> <p>Checks may be made by our UK based team prior to travel, or during your trip by your tour leader. If you are unable to provide proof when requested on the trip, you will need to take a COVID test locally, at your own expense.</p>
<p><b>Before travelling you will need to:</b></p>	
<ul style="list-style-type: none"> <li>Obtain an FFP2 face covering</li> </ul>	<p>FFP2 face coverings differ from the cloth/surgical types generally used in the UK. They are available to purchase online or in most high-street pharmacies and are required throughout your journey to Italy.</p>
<p><b>While in Italy you will:</b></p>	
<ul style="list-style-type: none"> <li>Wear an FFP2 face covering on all public transport</li> </ul>	<p>An FFP2 mask is also required in all indoor entertainment venues.</p> <p>A standard mask is recommended in all indoor public spaces.</p>
