

## COVID travel guide for New Zealand

### ENTRY REQUIREMENTS:

FOR CUSTOMERS TRAVELLING FROM THE UK	
<p>There are no specific entry requirements for New Zealand in relation to COVID vaccination status. All travellers will therefore need to fulfil Exodus' COVID-Clear policy. Full details on this can be found <a href="#">here</a>.</p>	
<p><b>Prior to your trip, you will need to either:</b></p>	
<ul style="list-style-type: none"> <li>Be fully vaccinated against COVID</li> </ul> <p><b>OR</b></p> <ul style="list-style-type: none"> <li>Receive a negative COVID test result before travelling</li> </ul>	<p>The total number of doses must have been given, as required by the vaccine manufacturer (in most cases this is two doses), with the last dose having been administered no less than two weeks prior to travel.</p> <p>Please obtain a copy of your NHS COVID Pass for Travel and have this readily available during your trip. For guidance on how to obtain this, please go <a href="#">here</a>.</p> <p>If you are not fully vaccinated, please take a COVID test no more than 72 hours before departure. This can be either a PCR or lateral flow test.</p> <p>This must be a private test; information on COVID testing and private providers can be found <a href="#">here</a>.</p> <p>Checks may be made by our UK based team prior to travel, or during your trip by your tour leader. If you are unable to provide proof when requested on the trip, you will need to take a COVID test locally, at your own expense.</p>
<p><b>Before arrival you will need to:</b></p>	
<ul style="list-style-type: none"> <li>Obtain a New Zealand electronic travel authority</li> </ul>	<p>This can be completed <a href="#">here</a> and costs roughly £25. It takes up to 72 hours to process so we would recommend allowing plenty of time to complete it.</p>
<p><b>Following your arrival you will be encouraged to:</b></p>	
<ul style="list-style-type: none"> <li>Complete rapid antigen tests</li> </ul>	<p>You will be provided with a pack of tests with instructions for use. The first test can be taken the day you arrive and the second and final test on either day 5 or 6.</p> <p>You may receive an email from the Ministry of Health with instructions on how to report your result.</p>
