

## **COVID travel guide for South Korea**

## **ENTRY REQUIREMENTS:**

## FOR CUSTOMERS TRAVELLING FROM THE UK

There are no specific entry requirements for South Korea in relation to COVID. All travellers will therefore need to fulfil Exodus' COVID-Clear policy. Full details on this can be found <u>here</u>.

<ul> <li>Be fully vaccinated against COVID</li> <li>OR</li> <li>Receive a negative COVID test result before travelling</li> </ul>	The total number of doses must have been given, as required by the vaccine manufacturer (in most cases this is two doses), with the last dose having been administered no less than two weeks prior to travel. Please obtain a copy of your NHS COVID Pass for Travel and have this readily available during your trip. For guidance on how to obtain this, please go <u>here</u> . If you are not fully vaccinated, please take a COVID test no more than 72 hours before departure. This can be either a PCR or lateral flow test. This must be a private test; information on COVID testing and private providers can be found <u>here</u> . Checks may be made by our UK based team prior to travel, or during your trip by your tour leader. If you are unable to provide proof when requested on the trip, you will need to take a COVID test locally, at your own expense.

<ul> <li>Submit an online questionnaire on your health condition</li> </ul>	<ul> <li>The South Korean government encourage all travellers to complete in advance. Paper based alternatives are available on arrival, but may result in a longer time to leave the airport.</li> <li>For the benefit of all group members, Exodus ask that our customers submit these online. This can be booked by going <u>here</u>.</li> <li>The form is called 'Q-Code Quarantine COVID19 Defence' – please be assured that there is no compulsory quarantine on arrival. This form is South Korea's version of a Passenger Locator Form.</li> <li>For your address in South Korea, please input the start hotel (Bestwestern Premier Kukdo Hotel). You will need to search for this using the ZIP Code, which is 04548. Under contact number, please enter the hotel's details, which are 8226466123.</li> <li>Upon completion you will be provided with a QR Code; please download this and have it readily available for inspection upon arrival in South Korea.</li> </ul>
While in South Korea you will:	
Be required to wear a face covering while indoors     and on public transport	Failure to adhere to this can result in a fine of approximately £62. Further details on local rules in relation to COVID in South Korea can be found <u>here</u> .
