### VISA APPLICATION PROCESS SUMMARY

**Visa required in advance:** Yes. You can either apply for an Indian eVisa or a Standard Visa which includes a visit to a branch of the Indian High Commission's Visa Facilitation Service (VFS).

**IMPORTANT NOTE IF APPLYING FOR E VISA:**

For e-Tourist Visa (**01 year / 05 years**), applicants of the eligible countries/territories may apply online minimum **4 days in advance** of the date of arrival. Such application can be made **120 days in advance from proposed date of travel**.

For e-Tourist Visa (**30 days**), applicants of the eligible countries/territories may apply online minimum **4 days in advance** of the date of arrival. Such application can be made **30 days in advance from proposed date of travel**.

To avoid any confusion, we recommend applying for the **1-year multiple entry E-visa**.

**When to apply:**

**30 days** before travel – eVisa – 30 days validity eVisa

**At least 12 to 8 weeks** before travel - standard visa & 1 year validity eVisa

*\*\*\*Please note lengthy delays have been reported for standard visa processing appointments so please ensure you book your in-person appointment as soon as possible as soon as possible\*\*\**

**Processing time**

Once payment is made, immediate confirmation email and then up to 72 hours for eVisa to be issued.

7 – 10 working days – standard visa (from appointment date)

## NOTES FOR VISA

There are two ways to apply for your Indian visa – either online through their e-tourist visa service, or through the Indian High Commission’s Visa Facilitation Service (VFS).

You can also choose to apply through our recommended visa service agency [Travcour](#) please note for standard visas, **you will still need to attend an in-person appointment for your visa** application even if you use an agency service.

**\*Clients with a Pakistani passport or of Pakistani descent will need extra time and additional documents for visa processing.**

### 1. E-TOURIST VISA

- **30-day eVisa**

This is a double entry visa and is valid for entry within 30 days from the date the E-visa is granted. You can only apply for this type of visa only within 30 days of travel.

- **1-year eVisa**

This is a multiple entry visa and is only valid for 1 year from the date the visa is issued. You can apply for this type of visa within 180 days of travel

### 2. VISA FACILITATION SERVICE (VFS Global)

All applicants applying for a visa through VFS must **\*\*complete the [online form](#) and have it handed in to a branch of the Indian High Commission’s Visa Facilitation Service (VFS) to complete the process.** This can either be done in person, via a nominated person on behalf of the applicant or using the service of a visa service agency.

*\*\*Filling or submitting the online form on the Government website does not complete the process - you are required to submit the physical application form and supporting documents to the VFS Application Centre in person.*

Completing the online application form includes the requirement to enter two referee details (one at home and one in India) plus details of your start hotel; we provide details below on a trip-by-trip basis. British passport holders whose parents were not born in the UK should contact their nearest Indian Embassy to check the visa application conditions.

The photos required for the visa must measure 2” x 2” (50mmX 50mm) and are available from Snappy Snaps and some Post Office/superstore photo booths.

### USING THE INDIA E-VISA SERVICE

#### Normal process

- Read the instructions to ensure you meet all the requirements, especially around the entry points and type of visa available.
- Check the documentation required, including the digital photograph info, which is very specific.

## USING THE INDIA VISA FACILITATION SERVICE (VFS Global)

### Two stage process

1. Complete the online application form:
  - To apply for the Indian visa, you need to go through the Indian High Commission's Visa Facilitation Service (VFS) website (<http://www.vfsglobal.com/India/UK/>).
  - Complete the application and declaration forms. You can choose to pay for the visa online or at the appointment.
  - At the end of the online application process, you will need to make an appointment at one of their 14 branches (see below) to submit the application.
2. Visit your chosen visa application Centre at the time of the appointment:
  - Submit the documents
  - Pay the visa fee (if not already paid online)
  - You are also now required to submit a photocopy of the photo page of your passport attached to the printed online application form, the signed declaration, and a hard copy photo.
3. A family member or nominee is entitled to submit a visa application on behalf of the applicant, provided they have a letter of authorization signed by the applicant
