

EXODUS ADVENTURE TRAVEL “RADICAL SABBATICAL” CONTEST OFFICIAL CONTEST RULES

NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE OR OTHERWISE IMPACT YOUR CHANCES OF WINNING IN THIS CONTEST.

1. KEY DATES:

The “Radical Sabbatical” (the “**Contest**”) begins on March 4th, 2024, at 12:01 a.m. Eastern Time (“**ET**”) and ends on May 1st, 2024, at 11:59 p.m. ET (the “**Contest Period**”).

2. ELIGIBILITY TO ENTER:

The Contest is open only to legal residents of Canada (excluding Quebec) who are of the legal age of majority in the province in which they reside, and to legal residents of the United States of America (excluding the States of New York and Florida), who are at least 21 years of age. Employees (and those with whom such persons are living, whether related or not) of Zegrahm Expeditions, Inc. (the “**Sponsor**”) its parent companies, subsidiaries, affiliates, representatives, agents, distributors, prize suppliers, advertising/promotion agencies and any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfilment of the Contest (collectively, the “**Contest Parties**”) are not eligible to enter. Age and residency requirements must be met at the time of entry into the Contest. No purchase necessary or expected to participate. Void where prohibited or restricted by law.

In order to enter the Contest the entrant must be able to commit to a minimum of fifty (50) consecutive days in a calendar year in order to travel and partake in the Prize (as defined below). The Entrant must also have a personal Instagram account which they actively use at the time of entering the Contest and for a period of 12 months following the end of the Contest Period.

3. AGREEMENT TO BE LEGALLY BOUND BY RULES:

By participating in this Contest, you are signifying your agreement that you have read and agree to be legally bound by these Official Rules and Regulations (the “**Rules**”). Failure to comply with these Rules may result in disqualification from the Contest.

4. HOW TO ENTER:

No purchase necessary. Internet access required. During the Contest Period, you can enter the Contest by visiting <https://www.exodustravels.com/us/radical-sabbatical> (the “**Website**”) and completing the entry form which is contained on the Website (the “**Entry Form**”). As part of completing the Entry Form, you will be required to upload a video to the Sponsor which must be submitted with your Entry Form (the “**Entry Video**”). The Entry Video must be at least 30-seconds in duration explaining why you are passionate about adventure travel and ready for a “Radical Sabbatical”.

Although it is a requirement that you have an Instagram account to enter the Contest, the Contest is in no way sponsored, endorsed or administered by, or associated with Instagram. Any questions, comments or complaints regarding the Contest must be directed to the Sponsor and not to Instagram.

When all required steps of the entry process are complete, you will automatically be eligible to earn one (1) entry (an “**Entry**”) in the Contest. To be eligible, all content and materials associated with your Entry (collectively, the “**Entry Materials**”) must: (i) be submitted and received in accordance with these Rules during the Contest Period; and (ii) be in compliance with these Rules, including, but not limited to, the Participation Requirements listed below (all as determined by the Sponsor in its sole and absolute discretion). Standard data rates apply to participants who choose to participate in the Contest via a mobile device (please contact your service provider for pricing and service plan information and rates before mobile device participation).

5. ENTRY LIMIT AND CONDITIONS:

There is a limit of one (1) Entry per person. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) exceed any of the entry limits stated in these Rules; (ii) use multiple names, identities, e-mail addresses, accounts and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or to disrupt the Contest; and/or (iii) disrupt or participate in the Contest in any other fraudulent or misleading way, then they may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. The Contest Parties and each of their respective agents, employees, directors, officers, successors, and assigns (collectively, the “**Released Parties**”) are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed, incomplete or incompatible Entry Materials (all of which are void). Entry Materials will be rejected (and for certainty, an Entry will not be earned) if, in the sole and absolute discretion of the Sponsor: (i) the Entry Materials are not submitted

and received in accordance with these Rules during the Contest Period; and/or (ii) the Entry Materials are not in compliance with these Rules (including, but not limited to, the Participation Requirements listed below), all as determined by the Sponsor in its sole and absolute discretion.

6. VERIFICATION:

All Entries, Entry Materials and entrants are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an entrant's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry, Entry Materials and/or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of time for the purposes of the Contest will be the official time-keeping device(s) used by the Sponsor.

7. PARTICIPATION REQUIREMENTS:

BY ENTERING, YOU AGREE THAT YOUR ENTRY AND ENTRY MATERIALS COMPLY WITH ALL CONDITIONS STATED IN THESE RULES. BY ENTERING, YOU ALSO AGREE TO RELEASE THE RELEASED PARTIES FROM ANY AND ALL LIABILITY IN CONNECTION WITH THE CONTEST AND YOUR PARTICIPATION THEREIN AND TO INDEMNIFY THE RELEASED PARTIES AGAINST ANY AND ALL CLAIMS, DAMAGES, LIABILITIES, COSTS, AND EXPENSES ARISING FROM YOUR PARTICIPATION IN THE CONTEST. THE RELEASED PARTIES WILL BEAR NO LIABILITY WHATSOEVER REGARDING: (I) THE USE OF YOUR ENTRY MATERIALS; (II) PARTICIPATION IN ANY CONTEST-RELATED ACTIVITIES; (III) ANY USE, COLLECTION, STORAGE AND DISCLOSURE OF ANY PERSONAL INFORMATION; AND/OR (IV) IF DECLARED A WINNER, THE PRIZE (INCLUDING ANY TAX LIABILITIES AND USE OR MISUSE OF THE PRIZE). THE RELEASED PARTIES SHALL BE HELD HARMLESS BY YOU IN THE EVENT IT IS DISCOVERED THAT YOU HAVE DEPARTED FROM OR NOT OTHERWISE FULLY COMPLIED WITH ANY OF THESE RULES. THIS RELEASE AND INDEMNITY SHALL CONTINUE IN FORCE FOLLOWING THE TERMINATION OF THE CONTEST AND/OR AWARDING OF ANY PRIZE.

8. PRIZE:

There will be one (1) prize available to the winner which shall consist of adventure holiday itineraries which are organized by the Sponsor and which in total shall last for a minimum of fifty (50) days. The adventure holiday itineraries shall be from the Sponsor's products as currently displayed on the Sponsor's website at www.exodustravels.com (the "Prize") as may be amended from time-to-time. The Prize shall be for one (1) person only and must be used by the winner of the Prize only. In no event will the Sponsor be liable to award more than the number of Prizes as provided in these Rules. Should the winner wish to be accompanied by any other person or party on any part(s) of the Prize, then such party shall be required to pay the prevailing rates which are available on the Sponsor's website at www.exodustravels.com.

The destinations of the Prize and the scheduled itineraries shall be selected by the Sponsor in its sole discretion. The Sponsor reserves the right to amend or vary the itineraries at any time (including throughout the duration of the winner's use of the Prize). The Prize shall be for a minimum of fifty (50) consecutive calendar days but this may be extended in the sole discretion of the Sponsor in order to allow for, without limitation, transport and/or transfer from one destination to another. Within 10 days of being confirmed as the winner of the Contest, the winner shall be required to notify the Sponsor of the first day that they are free to begin the 50 day period. The first day must be on or before October 1, 2024. The Sponsor shall use all reasonable efforts to ensure the continuity of each holiday itinerary following the completion of another itinerary. However, this may not always be possible and there may be gaps between the scheduled dates of the itinerary. In such circumstances, the winner shall be provided accommodation in either the country in which the previous itinerary finished or the country in which the next itinerary shall begin. The accommodation shall be booked, and paid for by, the Sponsor.

The Prize shall include all airfares which are necessary for you to use the Prize in economy class only with one (1) checked-in hold bag and two (2) cabin bags.

However, the Prize does not include and the winner shall be responsible for arranging anything which is not expressly contained in these Rules and includes, without limitation, food and drink not outlined (or any other refreshments) in the itinerary which is provided to you; insurance, visas or other travel documentation; vaccinations (if applicable and required); specialty car hire; any events or activities not outlined in the Sponsor's published itineraries or the itineraries that are provided to the winner.

As a condition of participating in the Contest, entrants agree and acknowledge that in order to receive the Prize and be deemed a winner, entrants must agree to the terms herein, including but not limited to the prize conditions, the Sponsor's booking terms and

The potential Prize winner's failure to timely return any required forms may result in the potential winner being disqualified and, in such event, the Sponsor may select an alternate winner from among all remaining eligible entries, as determined by Sponsor in its sole and discretion. The Prize shall also consist of components which are provided by third party suppliers that are not connected with, or in the control of, the Sponsor. 9. ELIGIBLE WINNER SELECTION AND NOTIFICATION PROCESS:

The Sponsor shall create a prize committee of seven (7) panelists from employees of the Sponsor and the Sponsor's PR agency who shall select the winner ("**Committee**"). The winner shall be selected based on a personal and subjective determination of the Committee.

On May 1st 2024, in New York, New York at approximately 12:00 p.m. ET, the Committee shall review all eligible Entries that are submitted and received in accordance with these Rules during the Contest Period to select the Prize winner.

The winner shall be selected based on the determination, in the sole discretion of the Committee, of who embraces and has the greatest love for adventure travel based on the Entry Videos submitted by entrants. The Committee's decision shall be final. The Prize winner will be contacted by May 30th 2024.

The Sponsor or its designated representative will make a minimum of two (2) attempts to contact the potential winner(s) using the contact details which are provided by the potential winner in the Entry Form within five (5) US business days of the draw as set out above. The selected winner is solely responsible for ensuring they are able to receive notification messages, monitoring for such notification messages and following all instructions contained in such notification messages. The Sponsor accepts no liability for any errors or inaccuracies in the contact information provided by entrants in the Entry Form.

10. ELIGIBLE WINNER CONFIRMATION PROCESS:

WINNER MUST BE OFFICIALLY CONFIRMED BY THE SPONSOR IN ACCORDANCE WITH THE CONFIRMATION PROCESS SET FORTH HEREIN. If the potential winner is a resident of Canada, he/she will be required to correctly answer a mathematical skill-testing question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, in the Sponsor's form of declaration and release, or by telephone). the applicable Prize.
