## NOTES FOR VISA

There are two ways to apply for your Indian visa – either online through their e-tourist visa service **which Exodus highly recommends**, or through the Indian High Commission's Visa Facilitation Service (VFS).

You can also choose to apply through our recommended visa service agency [Travcour](#) please note for standard visas, **you will still need to attend an in-person appointment for your visa application** even if you use an agency service.

**\*Clients with a Pakistani passport or of Pakistani descent will need extra time and additional documents for visa processing.**

### 1. E-TOURIST VISA

- **30-day eVisa**

This is a double entry visa and is valid for entry within 30 days from the date the E-visa is granted. You can only apply for this type of visa only within 30 days of travel.

- **1-year eVisa**

This is a multiple entry visa and is only valid for 1 year from the date the visa is issued. You can apply for this type of visa within 180 days of travel

### 2. VISA FACILITATION SERVICE (VFS Global)

All applicants applying for a visa through VFS must **\*\*complete the [online form](#)** and have it handed in to a branch of the Indian High Commission's Visa Facilitation Service (VFS) to complete the process. This can either be done in person, via a nominated person on behalf of the applicant or using the service of a visa service agency.

***\*\*Filling or submitting the online form on the Government website does not complete the process - you are required to submit the physical application form and supporting documents to the VFS Application Centre in person.***

Completing the online application form includes the requirement to enter two referee details (one at home and one in India) plus details of your start hotel; we provide details below on a trip-by-trip basis. British passport holders whose parents were not born in the UK should contact their nearest Indian Embassy to check the visa application conditions.

The photos required for the visa must measure 2" x 2" (50mmX 50mm) and are available from most Post Office/superstore photo booths.

## APPLYING FOR YOUR VISA

### USING THE INDIA E-VISA SERVICE

#### Normal process

1. Visit this link: <https://indianvisaonline.gov.in/evisa/tvoa.html>

- Read the instructions to ensure you meet all the requirements, especially around the entry points and type of visa available.
- Check the documentation required, including the digital photograph info, which is very specific.

## Two stage process

### 1. Complete the online application form:

- To apply for the Indian visa, you need to go through the relevant Indian High Commission's Visa Facilitation Service VFS/BLS website:

- Complete the application and declaration forms. You can choose to pay for the visa online or at the appointment.
- At the end of the online application process, you will need to make an appointment at your nearest branch to submit the application.

### 2. Visit your chosen visa application Centre at the time of the appointment:

- Submit the documents
- Pay the visa fee (if not already paid online)
- You are also now required to submit a photocopy of the photo page of your passport attached to the printed online application form, the signed declaration, and a hard copy photo.

- A family member or nominee is entitled to submit a visa application on behalf of the applicant, provided they have a letter of authorization signed by the applicant

## VFS costs

The visa fee is: **£116 /US\$ 160 plus £3/US\$3** Counselor Surcharge

The VFS service charge is: **£15 / US\$15.90** (includes VAT and bank charges)

Total cost: **£134 / US\$178.90** (plus possible fee to use VFS courier service)

## Guidelines for Resizing Passport Photos for Visa Applications

When preparing your visa application, it's essential to ensure that your passport photos meet the specified requirements. Follow these steps to resize your photos effectively:

1. **Use Image Editing Software:** Instead of struggling with manual resizing, use image editing software. The Paint app on Windows computers or laptops is a suitable choice as well as the Preview App on Mac computers.
2. **Open the Photo in Paint:**
  - a. Launch the Paint app.
  - b. Open the picture you want to resize.
3. **Select the Resize Option:**
  - a. Look for the "Resize" button. It's usually located under the "View" tab.
  - b. Click on it.
4. **Adjust the Dimensions:**
  - a. In the Resize dialog, you'll see percentage fields for both horizontal and vertical dimensions.
  - b. Enter a value lower than 100 (e.g., 80) to reduce the photo size.
  - c. Click "Select" to apply the changes.
5. **Save the Resized Photo:**
  - a. Save the modified photo in a secure file you use often.
  - b. Close the Paint app.
6. **Check the File Size:**
  - a. Navigate to the location where you saved the file.
  - b. Verify that the photo now meets the recommended size (usually 1 MB or below).
  - c. This can be found on the right-hand side of the file if you have files saved under the detailed tab or alternatively if you hover over the document, it will specify the file size.

Remember to follow any additional guidelines provided by the visa website. By adhering to these steps, you'll ensure that your passport photos are professionally resized for your visa application.

### SMALL PRINT

*All nationalities require a full passport that must be valid for 6 months beyond the intended length of stay and need to **be within 10 years from date of issue**. It is your responsibility to have the correct personal documents and to obtain your own visa, if one is necessary, in accordance with the regulations of the country you are to visit.*

*If a visa is required prior to travel, it is your responsibility to obtain one. However, we strongly advise you not to do this until your trip has been confirmed as a guaranteed departure. The information above is meant to aid you in getting your visa. Information can change, so if you are at all concerned, please check with the embassy.*
